

August 14, 2017

The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7:00 pm. We recited the Pledge of Allegiance. Guests were welcomed.

Members Present: Curell, Harvey, Mohr, Running, Scheuer. Members Absent: None.

Visitors: Arlene Sullivan, Sherry Emerick, Cheryl Clark, Jack and Joan Knowlton, Ron Randall.

During Brief Public Comment time, comments were received about new gravel on township roads.

County Commissioner Cheryl Clark gave a report on various programs she is involved with, including the MAC 7 District Meeting, Hope Not Handcuffs, ASIS, Handle With Care, Human Service Meetings, and also stated they have started working on the County budget.

Motion by Running, supported by Curell to approve the agenda. MOTION CARRIED.

Motion by Curell, supported by Scheuer to accept into record the minutes of the July meeting with the following correction: 5 Zoning permits issued:

A. Gonzalez, Matthew (Ted Whitt) Old Greenhouse Purchased with Property, (Permit Never Acquired) 8462 Rich Road (Receipt # 4113 \$30.00)

B. Gonzalez, Matthew New Greenhouse 60x12. Project started without first acquiring a Permit (Receipt # 4114, \$30.00 + \$100.00 fine = \$130.00)

C. Gorsline, Harvey 8321 Heater, New Home Construction 56x30 (Receipt #4115 \$30.00)

D. Kesto, Mufeed Modular Home 1800 Sq. Feet 9593 Thayer (Receipt #4116 \$30.00)

E. D&J Bldg - Gary Harvey 8510 Rolling Acres pole bldg 20x30. MOTION CARRIED.

Motion by Running supported by Harvey to accept into record the Treasurers Report as presented. MOTION CARRIED.

Motion by Mohr, supported by Harvey to pay the monthly bills: from the General Fund, \$53,959.56 with checks numbered 12658 through 12671, from the Cemetery Fund, \$1128.09 with check numbers 1078 and 1079, and from the Mosquito Account, \$15,500 with check number 1057. MOTION CARRIED.

Supervisor Scheuer gave an update on various ordinance violation situations including the dangerous building on Silverwood Road, McIntyre Road, and a Rich Road location where it appears there was an addition to a house where no permits were acquired.

Mosquito Abatement Program was discussed.

Supervisor Scheuer gave an update on roads - gravel, brining and roadside mowing. The County had a breakdown with their mower and the mowing on some of the paved roads has not been completed yet.

There was discussion about Township insurance. Motion by Running, supported by Curell to pay the Accident Fund insurance. MOTION CARRIED.

The Board discussed having a complaint form for zoning violations. Further discussion was tabled until next month.

Thank you to Cindy Harvey, she is going to work on coming up with a letterhead to use for township correspondence.

Scheuer and 2 Planning Commission members, Robinet and Papiez, attended a MTA workshop about Medical Marijuana. Motion by Curell, supported by Harvey to reimburse Scheuer for the cost of this workshop. MOTION CARRIED.

There were 3 zoning permits issued since the last meeting:

A. Hurd, Daniel and Celeste (Pole Barn) 40x60 9280 Graves Rd

B. Vires, Luke/Artfully Crafted Pole Barns (Pole Barn) 40x24 7204 Nelson Lane

C. Vires, Luke (New Home 2 story)28x32 1200 Sq Ft 7204 Nelson Lane

Items mentioned during public comment time were a pavilion for the yard at the township hall, paving all or a portion of the township hall parking lot, the water hydrant in Section 1 at the cemetery is leaking, and there are dead trees at the cemetery that will need to be taken down soon, possibly in the winter.

Motion by Curell, supported by Harvey to adjourn. Meeting adjourned at 8:35 pm.
