Motion by Curell, supported by Mohr to accept into record the minutes of the November meeting as drafted. MOTION CARRIED.

Motion by Running, supported by Harvey to accept into record the Treasurers Report as presented. MOTION CARRIED.

Motion by Curell, supported by Mohr to pay the monthly bills as follows: from the General Fund, \$20,297.46 with checks numbered 12510 through 12534, and from the Cemetery Fund, \$125.00 with check number 1063. MOTION CARRIED.

Motion by Harvey, supported by Curell to approve the proposed meeting dates for 2017 of the second Monday of each month at 7 pm. MOTION CARRIED.

Motion by Curell, supported by Running to accept the resignation of David Scheur from the Planning Commission effective immediately. MOTION CARRIED.

Motion by Curell, supported by Running that, upon recommendation by the Supervisor, Michael Papiez be appointed to the Planning Commission to fill the remainder of the term left vacant by the resignation of David Scheuer. MOTION CARRIED.

Motion by Running, supported by Scheuer to reappoint Jim Robinet, Gary Curell, Krystal LaBair, and Darlene Lott to the Planning Commission for a term of 2 years, calendar years 2017 and 2018. MOTION CARRIED.

Motion by Curell, supported by Mohr to reappoint David Smith, Garry Running, Jerry Strich, and Leroy Myers to the Rich Township Board of Review, with Leroy Myers being an alternate to serve in the absence of any member. MOTION CARRIED.

We received a report on ordinance enforcement issues including McIntyre Road and the greenhouse on Rich Road. There was also some discussion about solar farms.

Motion by Scheuer, supported by Curell to purchase 2 laptop computers for use by the treasurer and supervisor. MOTION CARRIED.

There was 1 zoning permit issued since the last meeting: to Michael & Katherine O'Grady at 7007 Silverwood Road for a pole barn.

Motion by Curell, supported by Scheuer to pay the Office Depot bill of \$1440.40 for the printing and mailing of the tax bills so as not to go over our credit limit on the credit card. MOTION CARRIED.
