

June 12, 2017

The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7:00 pm. We recited the Pledge of Allegiance. Guests were welcomed.

Members Present: Curell, Harvey, Mohr, Running, Scheuer. Members Absent: None.

Visitors: Arlene Sullivan, Sherry Emerick, Keith & Mariann Fleckenstein, Cheryl Clark, Gary Cooley, Mark Jaruzel, Lee Myers.

Motion by Curell, supported by Mohr to approve the agenda. MOTION CARRIED

Motion by Curell, supported by Harvey to accept into record the minutes of the May meeting with the following correction: there was one zoning permit issued since the April meeting, to Shawn and Jennifer Johnson 8359 Mowatt Rd for a 30 X 40 pole barn. MOTION CARRIED.

Motion by Mohr, supported by Running to accept into record the Treasurers Report as presented. MOTION CARRIED.

Motion by Curell, supported by Scheuer to pay the monthly bills: from the General Fund, \$17,975.27 with checks numbered 12612 through 12639, from the Cemetery Fund, \$1335.68 with check numbers 1074 and 1075, and from the Mosquito Account, \$15,500 with check number 1055. MOTION CARRIED.

Motion by Curell, supported by Scheuer to purchase 1200 gallons of propane from Harmon Oil through their pre-buy program for the 2017-2018 season. MOTION CARRIED.

The grading and brining of our township gravel roads is approximately 80% completed.

Motion by Running, supported by Curell to have Jostock Trucking perform single-pass roadside mowing on our township roads for \$3500 as proposed. MOTION CARRIED.

Motion by Curell, supported by Scheuer to instate a \$100 fine in addition to the \$30 zoning permit for anyone who begins a building project without first obtaining the zoning permit. This fine becomes effective July 1, 2017. MOTION CARRIED. Scheuer will check with township attorney to make sure this is being done properly.

Motion by Curell, supported by Scheuer to purchase assessing.net from BS&A Software as proposed by BS&A. MOTION CARRIED.

Motion by Scheuer, supported by Curell to adopt Ordinance No. 13.1 to amend our Ordinance Designating Enforcement Officers No. 13 as adopted on April 9, 1985.

County Commissioner Cheryl Clark spoke briefly about identity theft. She has applied to receive copies of a booklet on the subject that she will make available to those interested.
