

September 11, 2017

The Rich Township Board met at the Township Hall. The meeting was called to order by Supervisor Scheuer at 7:00 pm. We recited the Pledge of Allegiance.

Members Present: Curell, Harvey, Mohr, Running, Scheuer. Members Absent: None.

Visitors: Arlene Sullivan, Sherry Emerick, Jack and Joan Knowlton, Garry Running, Keith and Mariann Fleckenstein.

Motion by Curell, supported by Mohr to approve the agenda. MOTION CARRIED.

No comments were received during Brief Public Comment time.

Motion by Curell, supported by Harvey to accept into record the minutes of the August meeting with the following correction: There was a motion by Curell, supported by Mohr to not take action on the list of complaints with pictures, that was presented by a resident. MOTION CARRIED.

Motion by Running supported by Harvey to accept into record the Treasurers Report as presented. MOTION CARRIED.

Motion by Mohr, supported by Curell to pay the monthly bills: from the General Fund, \$19,475.30 with checks numbered 12672 through 12696, from the Cemetery Fund, \$1325.86 with check numbers 1080 and 1081, and from the Mosquito Account, \$15,500 with check number 1058. MOTION CARRIED.

Supervisor Scheuer gave an update on ordinance violations. Mr. Rexin, the owner of the dangerous building on Silverwood Road says he will have it down by September 30, as agreed at the Dangerous Building Hearing held in April. There was also discussion about the McIntyre Road violation where there has been no response to any communication sent to the owner. Scheuer may write a ticket and request a formal hearing. He will check into posting the ticket at the property.

The final payment for mosquito control for this year is being made to APM. Scheuer will request reports from APM on their work in our township.

Grading and brining of our township roads has been completed. There will be some work done on ditches.

Supervisor has received bids, 1 written, 1 verbal on a generator for the township hall. There was some discussion about a pavilion at the township hall and paving the parking lot.

There were 3 zoning permits issued since the last meeting:

Lynn Thompson for a 32x30 modular home at 466 W Castle Road

Gary Fischer for a 30x18 Glass Patio at 7272 N Lapeer Road

Lorraine Curell for a (home addition/alteration) kitchen and porch at 7755 Rich Road

Motion by Curell, supported by Harvey to pay \$50 per diem for Supervisor, Treasurer and Clerk to attend meetings of the county supervisor, treasurer, or clerk's groups. MOTION CARRIED.

Motion by Curell, supported by Harvey to pay the Supervisor mileage for travel for township business and \$30 for each ticket issued. MOTION CARRIED.

There were 4 items of correspondence: a pipeline safety booklet, a letter from the Lapeer Library about "Little Libraries", the County Annual MTA meeting to be held at Deerfield Township on October 21, and electronic recycling being held at Burnside Township on Saturday, September 16.

Motion by Curell, supported by Mohr to adjourn. Meeting adjourned at 8:01 pm.
